
What does Title IX mean in Interscholastic Athletics?

 - Public awareness campaign
 - Educate schools, the public and especially parents

College Sports Council

- Advocacy group for Title IX reform
 - Letter to all 12 regional OCR offices

- Chairman
 - "applying the three-part test will result in the elimination of boy's teams"
 - Conceded he did not know of any current examples

LEGISLATION

 - January 26, 2011

- Completion and submission of annual Title IX self-audits
 - US Department of Education

Girls' Sports Participation Continues to Rise

National Federation of State High School Associations (NFHS) report from 2009-2010 participation in high school sports has never been higher.

Girls increased by 58,546 - Boys increased by 33,078

Bad News??

Girls comprise 49% of interscholastic population

Receive 41% if all participation opportunities nationwide

Approximately 1,300,000 fewer opportunities
