### PETE ADVOCACY IN TOUGH ECONOMIC TIMES

• What is the *value* of your PETE program?

- State level childhood obesity rates
- Academic performance and health related fitness
- Advocacy and publicity is the key!
- Publicizie "good news" regarding teaching, research and service.
  - This message must be heard *prior to* times of cutbacks and furloughs!

### **KINESIOLOGY CASE STUDY**

- To provide academic departments and administrative leaders with the information and tools necessary to both survive and thrive during times of economic uncertainty in higher education.
